MISSOURI SOCIETY OF PROFESSIONAL LAND SURVEYORS BOARD OF DIRECTOR'S MEETING

President Robert Ubben called the meeting to order.

<u>Minutes of the May 8, 2014</u> Board of Directors meeting was reviewed. A motion was made and seconded to accept the minutes as presented. On a vote, this motion was approved.

<u>Financial Report</u>: The financial report through July 2, 2014 was reviewed showing a checking account balance of \$6,342.90 with total assets in the amount of \$161,134.15. **A motion was made and seconded to accept the financial report as presented**.

<u>REGISTRATION BOARD REPORT</u>: Mike Freeman, absent. An email was sent reporting that the test results were dismal and numbers continue to decline, both takers and passers. The revision to RSMo 327.272 will go into effect next month.

LAND SURVEY ADVISORY COMMISSION: No report.

STATE LAND SURVEYOR REPORT: Darrell Pratte reported that the Minimum Standards had not been promulgated and were still with the Director of the Department of Agriculture. He reported that the Land Survey Program had taken in \$1.1 million, the lowest amount in many years, yet the program had a balance at the end of the fiscal year of \$975,519.

<u>NSPS GOVERNORS REPORT</u>: NSPS Governor Troy Hayes, absent. It was reported that the NSPS meeting will be held at the same location and time as the joint annual meeting with KSLS.

CHAPTER REPORTS:

Kansas City: No report.

<u>St. Louis</u>: Chuck Quinby reported on the "Survey Party at the Arch" and the media coverage associated with this event. He also returned \$500 from the MSPS donation that was not needed. A full coverage article will appear in the next issue of the Missouri Surveyor.

<u>Ozark</u>: It was reported that the chapter continues to have chapter meetings where they have PDUs available for education. The chapter is doing a Boy Scout badge project with the help of several associate members and are looking forward to a workshop that the Southwest chapter is holding with Wendy Lathrop speaking.

Southeast: No report.

<u>Southwest</u>: It was reported that a workshop featuring Wendy Lathrop was scheduled for August.

COMMITTEE REPORTS:

<u>Annual Meeting Committee</u>: It was reported that NSPS would be having their Board of Governors meeting at the same time and location as the joint Missouri/Kansas meeting in October in Overland Park, KS. All other plans are in place for the meeting.

They are proposing to coordinate a Minimum Standards presentation via a webinar whereby MSPS would make 25% of the profit from the webinars. There were other issues that came up such as MSPS having control over the registration information and MSPS tracking PDUs. Board members Adam Teale and Robert Ubben volunteered to work with Joe Paiva to get this program off the ground.

GIS/Vision 21 Committee: Joe Clayton, Chairman, had no report.

Handbook Committee: Norman Ellerbrock absent. No report.

<u>History Committee</u>: Stan Emerick reported on the next project for the committee of the 200th anniversary of the St. Louis Public Land Office and the principal meridian in 2015, as well as the marking of the grave of Joseph C. Brown that is in the St. Louis area. He also reported that he has framed prints from the collection of Bill Kankolenski that will be up for the silent auction in October at the meeting.

Legislative Committee: Rich Barr discussed the MSPS education bill and problems with proceeding with Rep. Burlison as the chairman of the Professional Registration committee. He suggested that the Board and committee look at the language that Adam Teale had

prepared as a substitute for the current language.
