Hotel Accommodations

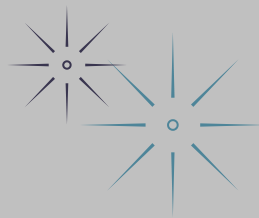

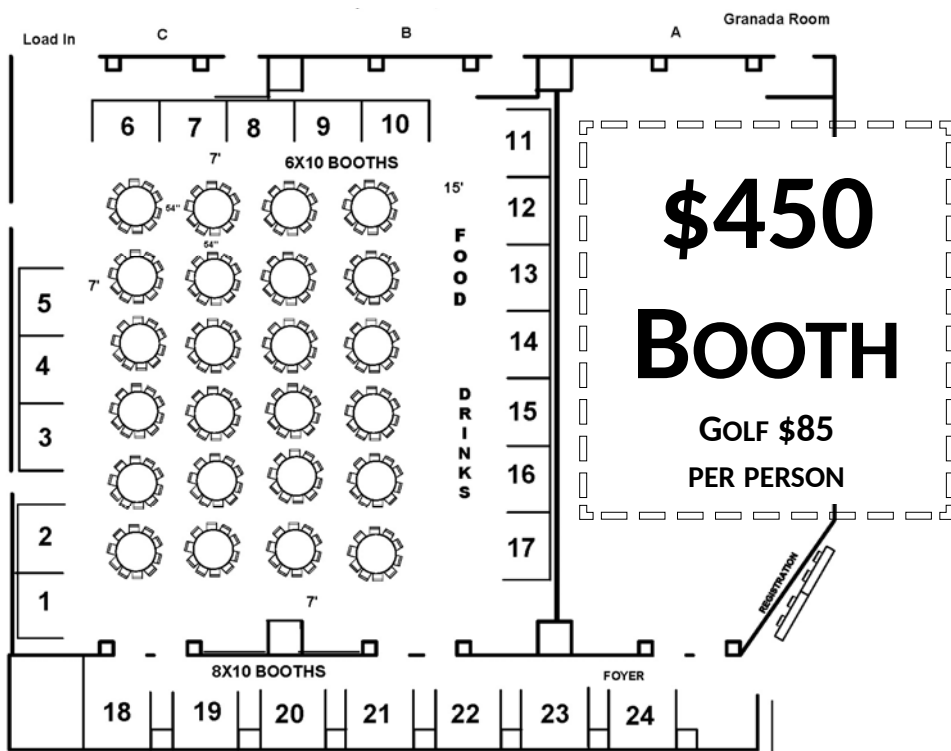
